Total program expenses were \$3,143,704. Total program revenues were \$68,478.

Alternative Payment Program consists of the CDE Contracts C2AP, C3AP and CAPP and offers full or partial child care subsidies to (need and income) eligible families through a voucher program. See Schedule O for further details. Total program expenses were \$2,645,116. Total program revenues were \$18,659.
